Health Insurance

Options for you and your Family

If you are under 26, you have the option to remain on your parent's plan from their job or the Marketplace. By law, you must have insurance or you will likely pay a fee.

Each person in your family may qualify for a different option.

Health Insurance from your Job

Ask your job about the **cheapest** health plan that covers **only the employee**. If the monthly amount you pay for this plan is less than 9.69% of your family's income, it is considered affordable.

2. Medicare

You must be 65 or over, OR receiving Social Security Disability, OR have end-stage kidney disease.

You can still sign up for The Marketplace if your income is higher, but you will not get financial help.

Missed the deadline? Sign up within 60 days of:

- Loss of coverage Loss of employer coverage from a job, turning 26 and losing parent's insurance,
- Release from incarceration
- Changes in household size Birth or adoption, marriage, divorce, legal separation, death
- Immigration Gain of citizenship or lawful presence in the U.S.
- Moving

A permanent move out of county that results in access to new plans

Tribal Membership Members of a federally recognized tribe may enroll at any time
